This is regarding Compliance Report submitted by **Dhanalakshmi Srinivasan Engineering College, Thuraiyur Road, Perambalur-621 212, Tamil Nadu** for the UG Engineering programs which were accredited by NBA in Tier-II for academic years 2018-19 to 2020-21 whose validity of accreditation had expired on 30.06.2021. The programs were granted accreditation for the Academic Year 2021-22 i.e. upto 30/06/2022 on account of present pandemic situation due to Corona Virus.

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The programs have been granted accreditation for further 3 years. **Dhanalakshmi Srinivasan Engineering College, Thuraiyur Road, Perambalur-621 212, Tamil Nadu** should submit fresh online application under First Cycle SAR Tier-II June 2015 Document through eNBA portal at least five months before the expiry of validity of accreditation mentioned above.

5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **Dhanalakshmi Srinivasan Engineering College, Thuraiyur Road, Perambalur-621 212, Tamil Nadu** as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.
